

The Monroe County Board of Education met in regular session Thursday, April 8, 2010 at 7:00 p.m. in the Boardroom at the Director of Schools' Office. Seven Board Members present: Dr. Larry Stein, Chairman, Mrs. Lisa McLemore, Mrs. Sonya Lynn, Mr. Danny Isbill, Mrs. Janet Martin, Mr. Dean Williams, and Mr. Ron Eydt. Mr. Jerry Snyder and Mr. DeWitt Upton were absent.

Item No. 1: The Chairman asked for approval of the agenda for the regular meeting on April 8, 2010 with the additional item of a student transfer request from Sequoyah High School to Tellico Plains High School. Dr. Larry Stein made a motion, seconded by Mr. Danny Isbill to approve the amendment to the agenda. Motion passed. Mrs. Sonya Lynn requested that the agenda be amended to pull out Consent Agenda Items #9 a., b. & c. for discussion and requested to be added for a discussion under new business. Motion passed.

Item No. 25: Next was a discussion requested by Mrs. Sonya Lynn concerning TN Risk Management bids for the county liability insurance and discussion of the Board's lawsuit liability. Mrs. Lynn requested that the Chairman obtain information on the bids for the Board of Education's property and casualty insurance for the May meeting.

Item No. 26: The Director reported to the Board on the following: attendance awards will be given at the May meeting due to the ending date of the six weeks period; the Gifted Program received a \$20,000 grant; the Director has been meeting with supervisors to discuss extra duties for principals for the 12th month contract; Monroe Academy has graduated 24

students as of the week of April 8, 2010. The Director recognized Sweetwater FFA State Farm Business Contest Winners.
