He informed the Board that plans will be ready next week and will receive bids on May 8, 2007. Mr. Underwood discussed with the Board options for the Rural Vale water treatment plant. After a discussion Mrs. Sonya Lynn made a motion, seconded by Mr. Larry Stein to give Mr. Underwood permission to negotiate the purchase of up to five acres @ \$5,000 per acre for Rural Vale Elementary School. Motion passed. Mr. Underwood informed the Board that traffic flow will be a concern at Madisonville Primary School. Mr. Underwood also informed the Board that during the construction process Rural Vale Elementary will be without a gym and a cafeteria part of the time. He discussed that the gym area will be built first and get that done as soon as possible and possibly at spring break next year move the cafeteria workers to Tellico Plains High School to prepare meals and transport the meals to Rural Vale Elementary in storage containers.
